The University offers four week-long language courses (levels A1, A2, B1, B2) before the start of each semester for €100. Students will receive 3 ECTS upon completion. Students who would like to participate in this course must fill out the language course reservation

The University uses the European Transfer Credit System (ECTS) where 6 ECTS is equivalent to 1 UPEI course. A full study load per semester is 30 ECTS.

Accommodation

HFT does not provide on-campus accommodation. Instead, dormitories are provided by the Studierendenwerk Stuttgart (student housing association). Since the demand for housing is high, accommodation through the Studierendenwerk Stuttgart cannot be guaranteed. Requests must therefore be placed at the time of your application.

Dormitory rooms are furnished and have internet access. Every student residence is equipped with laundry facilities. Rent for single rooms range between €285 - €350. In general, students will need about €750 per month to cover living expenses. For more information, see: http://www.hft-
