

Memorandum of Agreement

THIS MEMORANDUM OF AGREEMENT is made this 21st day of October, 2024 between the **UNIVERSITY OF PRINCE EDWARD ISLAND BOARD OF GOVERNORS** (the "Employer") and **CANADIAN UNION OF PUBLIC EMPLOYEES, LOCAL 1870** (the "Union"). The parties agree that the collective agreement between the Employer and the Union executed on May 12, 2024, which is scheduled to expire on 30 April 2025 (the "Agreement"), is amended as follows.

Article **38.02** be amended as follows:

38.02 Both parties agree that either party may upon written notice as per this Article, give to the other party, notice of their intent, to re-open the Agreement by **April 30th, 2026**. The party requesting the re-opener shall specify in its request the Articles it wants to negotiate. The recipient of the notice shall also be given the opportunity to specify any Articles it may want to re-open and shall enter into negotiations within twenty (20) working days of receipt of such notice.


Appendix A of the Agreement will be amended to include a 3% wage increase effective May 1, 2025. These changes are reflected in the attached Appendix A to this Memorandum.


