# CARTER BRAY EXECUTIVE MBA SCHOLARSHIP

#### DESCRIPTION

A native Islander, Dr. James (Jim) Carter is known as a visionary business and community leader. He attended Prince of Wales College and UPEI. Having worked for Syncrude Canada Ltd. for 28 years, his work has contributed to improvements in environmental performance, workplace safety and strengthening relations with aboriginals. His wife, Dr. Lorraine Bray, is a Psychologist. Together, they have six adult children and reside in Alberta.

With a deep affection for Prince Edward Island, and respect for the importance of supporting students as they strive for excellence, Drs. Carter and Bray made substantial gifts to create this endowed fund that will provide for this scholarship in perpetuity.

### **ELIGIBILITY CRITERIA**

Scholarship applicants must meet the following eligibility criteria to be considered for this scholarship:

- Candidates must have applied for admission to the Executive MBA Program by June 30 and intend to begin the program in September of the same year.
- Candidates must be a resident of Prince Edward Island, have a record of good academic standing, and display financial need (as outlined in the personal statement submitted as part of the candidate's EMBA program application)
- Candidates receiving employer support and/or other graduate student awards that, combined, exceed 50% of the program's tuition and fees are not eligible for this scholarship

## **SELECTION CRITERIA**

Scholarships will be awarded to applicants based on the following criteria:

• Preference will be given to applicants that have made contributions to their communities or have exercised sustainable business practices

## **APPLICATION AND SELECTION PROCEDURES**

- Applicants who apply to the UPEI Executive MBA Program by June 30 will automatically be considered for these scholarships. The scholarship committee will have access to the applicant's resume, transcripts, letters of reference, and personal statement.
- Applicants are encouraged to review the selection criteria and address these points within their personal statement in their EMBA Program application.
- Selection will be based on the confidence of the committee that the student will continue to display exceptional leadership and be actively engaged in the EMBA Program.
