DESCRIPTION

This fund is provided by a grant to the University of Prince Edward Island Student Union by the Province of Prince Edward Island. These awards will help support students financially impacted by COVID-19.

The award is supported by the UPEI Student Union and the UPEI Scholarships & Awards Office within the Student Experience Hub of Dalton Hall.

CRITERIA

The COVID-19 Student Support Fund is designated for students that meet the following criteria:

- Were registered as a Full-Time student during the 2020 Winter Semester at UPEI
- Must be currently living in Prince Edward Island
- Preference will be given to applicants who have not previously received adversity funding through either the UPEI Student Union or UPEI's Scholarships & Awards Office

APPLICATION PROCESS (Deadline: May 15, 2020)

Applicants are required to submit a completed application booklet for the COVID-19 Student Support Fund to review.

The adjudication committee is comprised of representatives of the UPEI Student Union along with staff from the Student Experience Hub. Successful recipients will be contacted before May 20, 2020. Unsuccessful recipients will not receive further correspondence.
