## Mature Student Bursary Master of Cleantech Leadership & Transformation (MCLT)

The Mature Student Bursary supports learners aged 40 and above who are pursuing graduate-level studies through the Master of Cleantech Leadership and Transformation (MCLT) program at UPEI. The bursary covers the cost of one MCLT course per term (up to three terms annually).

- For students enrolled in the MCLT program: the bursary may be awarded once per semester, allowing recipients to apply for support each term.
- For students not enrolled in the MCLT program: the bursary may be awarded for one course per academic year.

Students who receive this bursary are encouraged to use the support to expand their learning opportunities.

The MCLT program follows an inquiry-based, interdisciplinary model that equips students with the skills, knowledge, and strategic mindset to drive cleantech innovation for a sustainable future. Its mission is to cultivate transformative leaders who:

- Pioneer collaborative solutions for net-zero transformation and beyond
- Integrate diverse perspectives, including scientific, social, and Indigenous knowledge
- Navigate policy frameworks and governance systems to advance sustainable implementation
- Lead strategic actions that inspire organizational and community-level change

By supporting mature learners in their studies, this bursary advances both individual career goals and the broader vision of building a collaborative community of eco-professionals capable of leading sustainable transformation locally and globally.

- Mature students 40 years of age and older
- Domestic and International Students
- Students enrolled part-time or full-time at UPEI
- Students enrolled in the MCLT program, OR students taking at least one graduate-level Cleantech course
