**3. REPORT OF THE PRESIDENT**

In his report to Senate, the President noted the celebration of the 2<sup>nd</sup> Annual Academic Integrity Week, with the theme "The Cost of Cheap Success," - January 16-20. The President also noted International Development Week - February 6-10, and extended congratulations to the organizing committee and award winners. The President acknowledged the events surrounding both Academic Integrity Week and International Development Week which placed UPEI in the spotlight. The events in History 322 and the publication in the CADRE of the infamous caricatures have tested and reinforced our quality and values as an academic community. While we would not choose to be embroiled in these controversies, it is incumbent upon us to address them as "learning moments." That process will continue, and we should expect to come away wiser and stronger.

The President also noted:

- The ABC Canada Family Literacy Day was held on January 27. Thanks to Vianne Timmons, Fiona O'Donoghue, and other colleagues for their part in leading UPEI's contribution.
- A quadruple book launch held on January 20, showcasing four recent publications by seven colleagues in the UPEI Faculty of Arts. Congratulations to Malcolm Murray, Neb Kujundzic, Ian Dowbiggin, Barry Bartmann, Henry Srebrnick, Irene Novaczek and Jean Mitchell.
- Marking a first in the history of UPEI, colleagues obtained a US Patent for a rat model of Epilepsy. Congratulations to Tracy Doucette (principal investigator) Cathy Ryan, Andy Tasker, Henrietta Husum and graduate student, Melissa Perry. The model facilitates research on epilepsy among adolescents, and provides clues as to how the disease actually develops.
- The search for several senior positions within the university is progressing well. The Search Committee for the Dean of Science will soon be developing a short list of candidates. The Search Committee for the University Librarian has presented a list of three candidates to be interviewed and presented to the university community. Biographical information on the three candidates was distributed to each Senator.
- Sr. Bernice Cullen has recently made a generous gift to the Robertson Library's University Archives that includes her certificates and diplomas from Saint Dunstan's University and Prince of Wales College. Also included in the gift is her 1941 Bachelor of Arts degree from St. Dunstan's University, which was the first degree ever granted by SDU.
- On February 11 and March 11, UPEI will host the PEI CanWest CanSpell National Spelling Bee competitions. On Saturday, Feb. 11 the written portion will be held in the Duffy Ampitheatre. The provincial Spelling Bee, which features the top 40 spellers from the written portion, will be held at 2:00 pm on Saturday, March 11 at the W. A. Murphy Student Centre.

- PEI High School Principals Annual Meeting will be held on campus on February 15, 2006
- The Distinguished Alumni Award Luncheon will be held on February 17 - Recipients are Lloyd Lockerby, Dr. Bill Dolan, Dr. Nancy Mathis, Dr. Sylvia Craig.
- UPEI Health Fair will be held on February 21<sup>st</sup> in the Student Centre

**4. Report on Curriculum Changes**

**School of Business -**

**Moved (R. MacDonald/D. Wagner)** : that Senate approve the following items from the School of Business

- Deletion of the Certificate in Finance and Economics.
- The following note be added below the description of Business 251 - NOTE: This is a required course for Business students and credit for Math 221 and Psychology 271 **will not** be allowed.

D. Ryan wondered at the degree of overlap between Business 251 and Math 221. He noted that if there was not significant overlap, allowing a Business student to receive credit for Math 221 could allow the student an opportunity to explore something they do enjoy outside their discipline. R. MacDonald noted that the faculty felt there was a significant overlap. D. Ryan suggested that it be made clearer to students that the overlap existed and double credit would not be granted. R. MacDonald noted that they would re-examine the course description for Business 251.

**5. SECOND REPORT OF THE ACADEMIC REVIEW PLANNING COMMITTEE**

R. Herbert introduced the new "Options" program designed to reconnect with academically suspended students. This non-credit program, which is being offered through Student Services, is available to students who are at the mid-point of their academic suspension from the University. Bob Gibson, Director of Student Services, was invited to speak on the program. Mr. Gibson indicated that there are twenty-six students presently registered in the program. Each student develops a portfolio relating to their individual career and education aspirations and plans. The class meets once a week for twelve weeks.

K. Schultz reminded Senators of the Strategic Research Plan Consultation currently underway. Faculty are encouraged to make a submission to the Research Advisory Committee. It is a web based consultation at this point. There are presently eight postings on the site. There will be two open meetings on Monday, February 20, and Friday, February 24.
