1. APPROVAL OF THE AGENDA

W. MacLauchlan called the meeting to order and noted that there were two Annual Reports listed on the agenda which will not be included in this meeting - Research Advisory Committee and University Writing Council.

2. APPROVAL OF MINUTES - May 3, 2006

Moved (G. Pike/D. Buck): that the minutes of May 3, 2006 meeting be approved.

3. ELECTION OF VICE-CHAIR

The Chair called for nominations for Vice-Chair. J. Moran nominated David Buck. There were no further nominations received. **Moved (J. Moran/V. Timmons)**: that David Buck serve as Vice-Chair by acclamation.

4. BUSINESS ARISING FROM MINUTES OF MAY 3, 2006

The Chair brought forward an item highlighted in the Annual Report of the Honorary Degree Committee presented to Senate at the May 3 meeting. The Committee feels that Senate should be asked to review the process for conferring the rank of Professor Emeritus. Historically, this was done by the Honorary Degree Committee. The Chair discussed the issue with James Moran, Chair, Nominating Committee and it was decided that a three person task force be formed to look at UPEI's practice and report back to Senate.

Moved (J. Moran/J. Velaidum): that the Nominating Committee bring forward to Senate names for a three-person task force consisting of a member of the University Review Committee, one member of the Honorary Degree Committee and a Senator at Large to look at UPEI's policies and process for conferring the rank of professor emeritus.

5. PRESIDENT'S REPORT

- The Chair welcomed new Senators Doug Dahn, Alfonso Lopez, Peter McKenna, and Mary McNiven who is replacing Chris Riley who is on sabbatical for this academic year. Returning Senators (for a further term), Dan Ryan, David Buck, Wimal Rankaduwa and Joe Velaidum were also welcomed. The Chair also thanked Kevin Teather, Lisa Miller, Elizabeth Spangler, and Scott Lee for their service on Senate.
- Week long activities for New Student Orientation (NSO) very active and enthusiastic group of incoming students. Shinerama raised more than \$16,000 for cystic fibrosis research.
- UPEI is welcoming a group of 12 new faculty members. As part of their orientation they participated along with other colleagues in a Seminar, "Let's Talk Teaching". As well, a reception and dinner will be held on September 8 to welcome new colleagues.
- Dr. Jane McGrath was awarded the Janet Pottie Murray Award for Educational Leadership.
- We welcome the new Visitor to the University, Her Honour Barbara Hagerman, Lt. Governor of PEI

- The new University Librarian, Mark Leggott, will assume his new role on October 1st.
- The National Survey of Student Engagement (NSSE) has been completed and analysed. There are generally positive results of student experience and satisfaction. Dr. C. Keen will be asked to prepare a presentation for the benefit of Senators.
- Faculty Development Summer Institute (FDSI) was held July 31 Aug 4 with a focus on Active Learning and Teaching. Professors and instructors from as far as the UK and Saudi Arabia, as well as from every province in Canada and from four US states took part
- First Annual Julian Jaynes Conference on Consciousness was held August 4-5. In the past, this was a one-day symposium.
- Third Annual Computer Science, Mathematics, Engineering, and Physics Undergraduate Research Symposium (CEMPURS) was held on August 10.
- UPEI was involved in the National IPAC Conference, held in Charlottetown, August 27-29
- UPEI Conference and Events hosted over 3800 people this summer at more than 60 different events
- Distinguished Visitor Speakers Series hosted eight speakers and was highly successful, with some events standing room only.
- Founder's Day was held on Thursday, Sept. 7 and was a successful celebration of our international connections. New Founders inducted were Elizabeth Epperly, Catherine Edward, Alfred Tsang, Larry Woo, Thomas Wong, and Albert Young.

Faculty of Arts

History

Change **History 309** - Science, Magic, Witchcraft and the Occult, 1300-1700 to **History 311** and a prerequisite be added - **History 201**.

Psychology

Psychology 461 - Change title from "Psychometrics" to "Psychological Assessment" - Change in Course

Description - This course provides an introduction to the theory and practice of psychological assessment with an emphasis on psychometric issues. The major approaches within the process are examined within multiple contexts such as clinical, school, and forensic settings. Students also gain experience in the application of fundamental assessment-related skills such as active listening, interviewing, and test administration.

Change in **prerequisites** from Psychology 101-102, 271-272 **to** Psychology 101-102, 271-272, 352 or permission of the instructor. Three hours per week

Change Psychology 452 to Psychology 462.

Change title from "Clinical Psychology" to "Psychotherapy";

Change in Course Description - This course provides an introduction to the theory and practice of psychological treatment of mental health problems. In addition to learning about the dominant contemporary approaches to psychotherapy, students will be expected to continue to build on the fundamental skills introduced in Psychology 461 as they relate to psychotherapy. Change prerequisites from Psychology 101-102, 271-272, 351 or 352 or permission of instructor to Psychology 101-102, 271-272, 352, 461 or permission of the instructor. Three hours per week

Psychology 322 - Add prerequisite Psych 242

Delete - Psychology 372 - Experimental Psychology

Sociology & Anthropology

Honours in Sociology

- a. Six semester hours of introductory courses: Sociology 101 and 102; or Anthropology 101 and 102; or Sociology 101 and Anthropology 102
- b. Twelve semester hours of required Sociology courses as follows: Sociology 301, Sociology 302, Sociology 331 and Sociology 332
- c. A six semester hour research course Sociology/Anthropology 490
- d. Twenty-one semester hours of Sociology or Sociology/Anthropology elective courses, as follows:
 - (1) two of either Anthropology 321; Anthropology 332; Anthropology 361
 - (2) Sociology/Anthropology 442
 - (3) one other Anthropology or Sociology/Anthropology course at the 300 or 400 level

To graduate with an Honours degree in Sociology, a student requires a total of 42 credits (126 semester hours).

- b. Twelve semester hours of required anthropology courses as follows:
 Anthropology 321; Anthropology 332; Anthropology 361; Anthropology 402.
- c. A six semester hour research course Sociology/Anthropology 490
- d. Twenty-one semester hours of anthropology or sociology/anthropology elective courses, as follows:
 - (1) two must be area courses;
 - (2) three must be at the 300 level; and
 - (3) two must be at the 400 level (excluding SAN 490)
- e. Twelve semester hours of Sociology or Sociology/Anthropology as follows:
 - (1) one of Sociology 301; Sociology 302; Sociology 331; Sociology 332
 - (2) three other Sociology or Sociology/Anthropology courses at the 300-400 level

To graduate with an Honours degree in Anthropology a student requires a total of 42 credits (126 semester hours).

Bus 465 - Project Management

Project Management is the application of knowledge, skills, tools and techniques to project activities to meet project requirements. The course emphasizes the design, scheduling, budgeting, and management of projects from a variety of fields

Prerequisite: Bus 252 and admission to Third year Business

Three semester hours

Bus 476 - Intercultural Management

This course examines the complex challenges that culture poses in international business. Topics include cultural influences on conducting business, values and communications, managing multicultural teams, international negotiations, and conflict resolution. The course aims to develop intercultural management education for working globally.

Prerequisites: Bus 287, admission to 3rd year Business or permission of the instructor

New Course

VCA 494 - External Clinical Experience-General Private Practice

This course provides an opportunity for clinical experience in general or community practice settings. This 1-3 credit-hour experience is limited to private practices that meet certain criteria as outlined in the senior rotation handbook. All expenses incurred are the responsibility of the student. This course is graded pass-fail. PREREQUISITE: Fourth year standing in the DVM program and approval of the departmental Chair and Associate Dean of Academic Affairs

Health Management

VHM 490 - change title from "External Clinical Experience" to "External Clinical Experience - Institutional or Specialist Practice"

New Courses

VHM 494 - External Clinical Experience-General Private Practice

This course provides an opportunity for clinical experience in general or community practice settings. This 1-3 credit-hour experience is limited to private practices that meet certain criteria as outlined in the senior rotation handbook. All expenses incurred are the responsibility of the student. This course is graded pass-fail. PREREQUISITE: Fourth year standing in the DVM program and approval of the departmental Chair and Associate Dean of Academic Affairs.

VHM 832 - Selected Topics in Biostatistics and Epidemiology

This course reviews current developments in frequently used statistical techniques and introduces the student to advanced biostatistical techniques such as multilevel modelling, survival analysis, or Bayesian methodology PREREQUISITE: VHM 801 or VHM 802 (preferred) and permission of the instructor

Moved (T. Ogilvie/L. Bate): that Senate approve the following changes in the Fourth Year of the DVM Program

THE FOURTH YEAR

The Fourth Year of the DVM program consists of at least 41 semester hours of credit comprising one 2 semester-hour didactic course (VHM 411) and elective clinical rotations.

Clinical rotations in Fourth Year must consist of at least 39 semester hours of credit selected from among approved 1-3 credit-hour elective rotations. Fourth year rotations require a minimum time commitment of 28 hours per week of each student, and emergency and out of-hours duties may be required. Normally, one week of fourth year rotation experience equates to one semester hour of credit.

Fourth year rotation selections comprising the required 39 semester hours of credit must meet the following criteria:

- 1. 27 semester hours of credit must consist of internal rotations offered by the AVC.
- 2. 6 semester hours of credit may consist of internal rotations offered by the AVC and/or external clinical experiences in institutional/specialist practices (VBS 490, VCA 490, VHM 490, VPM 490), and/or international veterinary medicine (VPM 410)
- 3. 6 semester hours of credit may consist of internal rotations offered by the AVC, and/or external clinical experiences in institutional/specialist practices (VBS 490, VCA 490, VHM 490, VPM 490), and/or international veterinary medicine (VPM 410), and/or external clinical experiences in general private practice (VCA 494 and VHM 494).
- 4. A minimum of 20 of the 39 rotation weeks must involve primary patient care as designated for internal rotations (P) or as designated by chairs for external and community practice rotations.
- 5. All students must take a core consisting of 15 weeks of internal rotations as follows:
 - a. Radiology (VCA 440) 3 weeks
 - b. Companion Animal (VCA 400) or Large Animal (VCA 450) Anaesthesiology 3 weeks
 - c. Companion Animal (VCA 410) or Large Animal Medicine (VHM 464) or Large Animal Medicine and Theriogenology (VHM 410) or Large Animal Medicine and Surgery (VHM 460)* 3 weeks
 - d. Companion Surgery (VCA 430) or Large Animal Surgery (VHM 450) or Large Animal Medicine and Surgery (VHM 460)* 3 weeks
 - e. Diagnostic Services (VPM 450) or Morphologic Pathology (VPM 460) 3 weeks
- 6 Either within the core, or in addition to the core, students must take at least 2 weeks in rotations that qualify as a large animal (LA) discipline and 2 weeks in rotations that qualify as a companion animal (CA) discipline.

NOTE: VHM 460* can be counted as <u>either</u> a Large Animal Medicine or a Large Animal Surgery rotation, but not both.

A maximum of 3 credit-hours will be assigned to an individual experience external to the AVC regardless of its duration. The expenses associated with external clinical experiences are the responsibility of the student. Students participating in an external clinical experience may receive a stipend to offset living and travel expenses but cannot receive credit for experiences where they are a salaried employees.
