OPEN SESSION

1. <u>Call to Order, Welcome, Land Acknowledgement and Opening Remarks from</u> Chair and Vice-Chair

W. Rodgers called the meeting to order, welcome members at 3:03 pm and acknowledged the land.

President Rodgers reminded Senators that next Tuesday marks the 10th anniversary of the Truth and Reconciliation commission report. The National Day of Truth and Reconciliation, also known as Orange Shirt Day; a day that honours the children who never returned home and survivors of residential schools, as well as their families and communities. The purpose of the day to reveal the truth of what happened because of the colonization of Canada and the imposition of the residential school system. One of the University's important roles is to uplift truth and deliver a more peaceful and respectful society. Senators are invited to consult the University's webpage on events planned to mark the day on campus.

As the agenda of this session is quite packed, we will move swiftly but will provide due opportunity for full discussion. Some regular items of business have been truncated to provide sufficient time to discussion important topics, such as the Audit of the Action Plan, the Strategic Enrolment Management Plan, the Policies on Harassment, Discrimination and Sexual violence and the University's Strategic Plan.

Vice Chair Mears Welcomed Senators to a new academic year and wished everyone a good semester.

2. Approval of Agenda

MOTION: MOVED by M. Turnbull and SECONDED by N. Clark that the agenda of Senate of May 2, 2025, be approved. CARRIED.

3. <u>Information Session on Action Plan Audit</u>

The Chair notes the presence of representatives of Deloitte; the auditors retained by the Board of Governors to audit the implementation of the Action Plan. The Auditors' Plain Language Report, a Reasonable Assurance Report, and a Recommendations Report were included in the meeting materials and are considered read.

T. Furgeson from Deloitte is invited by the Chair of Senate to speak and present to Senate a Report on the Audit of the University's Action Plan.

Furgeson indicates that the University has done a lot to get to this point, while stressing that institutional change at this scale takes time. He noted the University's organizational strength, commitment, and community engagement as elements of success in implementing the Plan. Auditors do have some recommendations to enhance the Plan's impact and note that the University should be proud of what has been accomplished. It is stated that Year 0 and 1 were implemented as planned. The Auditors therefore provide a clean audit opinion. To carry out the Audit, 68 criteria were developed and have formed the basis of their opinion. Of those criteria, none were not met, a few were partially met, and five were untested as they relate to the policies on Harassment, Discrimination and Sexual Violence, which are tracking towards approval by the Board of Governors in October.

The ambitious nature of the plan was noted, with auditors being uncertain that the University can fully deliver the plan over five years.

4. Approval of Minutes

a. September 26, 2025, Open Minutes

MOTION: MOVED by N. Etkin and SECONDED by M. Sweeny-Nixon that Senate approve the minutes of the open session of Senate of May 2, 2025. CARRIED.

Some discrepancies in attendance at the May 2 meeting were noted, with Senators invited to write to the Secretary with any required revisions.

6. Senior Administration Reports

a. President's Report

President Rodgers stated that the University has entered the "bring-it-on" phase of development of several key initiatives, some being on this meeting's agenda, as she marks the one-year anniversary of her coming to UPEI. She notes that once these initiatives are formally approved, the process of renewal doesn't end, that the University intends to regularly review its work, such that as the University moves important projects

over the line, we keep in mind that there will be opportunity to revisit them. As the University is moving forward, we are building resiliency, as we communicate better on how we are managing change. This is a time when we need to come together for the development of students, as we prepare them to meet the challenges of our times. Many have worked hard to get us here and deserve our thanks.

b. Vice-President Academic and Research Report

A written report from the Vice President Academic and Research was circulated with meeting materials and is considered read.

c. Vice-President People and Culture Report

As part of her listening tour, J. Nobia has completed 27 of 38 scheduled meetings and met 62 members of the University Community one-on-one. Meetings with students start in November and will continue in January. May comments received relate to cultural change. We are exploring in a shared way how we will change our institutional culture.

The University is now knee deep in the Year-2 of the Actin Plan with many important things to do. The *Harassment and Discrimination Policy* and the *Sexual Violence Policy* are key elements on our path forwards that must be brought to conclusion.

Many have expressed frustration with cumbersome processes that are getting in the way of good work. J. Nobia and T. Walker are reviewing core processes whose improvement would yield greater benefit. Nola Etkin has been appointed special advisor to help us in this process.

To address the harm caused and the resulting trauma in the University Community and help us move ahead together, we are hiring an expert in restorative practices.

New staff in the Sexual Balance and Prevention office are hired to prepare to deliver on the new Harassment, Discrimination and Sexual Violence policies.

7. Strategic Enrolment Management

Vice President Naderer presents a draft Strategic Enrolment Plan for 2025 to 2030 titled: *Roadmap to Student Success and Institutional Sustainability*. It is included in the meeting materials. The plan is meant to be a comprehensive effort to achieve our goals for enrolment, retention, and graduation.

The plan is predicated on:

 A student-centered roadmap that ensures enrolment growth is sustainable and that students have access to the advising, supports, and learning opportunities needed to experience an engaged learning journey, persist, and flourish in society when they graduate.

- Data-informed decision-making by using consistent dashboards, retention metrics, and enrolment projections, where SEM gives us the tools to better utilize evidence-based planning.
- Cross-campus collaboration and coordination across Faculties, Units, the Registrar's Office, Recruitment, Admissions, Institutional Research, ITSS, and Student Affairs.
- Each unit contributes to a shared accountability framework that keeps student success at the center of our daily work.
- Sustainability and growth that stabilizes international enrolments, expands graduate programs, improves domestic recruitment, and ensures revenue sustainability to support the University's mission.

The Plan is being developed through broad consultations, including this presentation to Senate, including workshops, subcommittee work, meetings of Dean's Council, etc., since 2024.

Thanks to members of the Steering Committee, to M. James as Chair of the Steering Committee, to Miles Turnbull as Chair of the Resource Planning Subcommittee and to Johnathn Hewitt as Chair of Student Success Subcommittee.

Plus speaks to projections in enrolment for coming years, given that we can deliver on the interventions outlined in the Plan.

M. Janes provides an update on the process to develop the SEM plan, current activities and opportunities for input and reminds members that SEM is about coordinating the strengths and capacities of the University to particular goals.

Questions:

- Q1: Do the goals related to graduate studies also apply to the creation of second undergraduate programs, i.e.: undergraduates that require a graduate degree at admission? A1: Nothing is off the table.
- **Q2**: What are the areas of recruitment? Are we looking at the American market? **A2**: Investment in markets where we have a strong presence. Yes, the American market is part of the plan.
- Q3: Can there be an information session in each unit about what degrees? A3: Yes, this would be an opportunity to discuss clear pathways for student success.
- **Q4**: Can there be more information for professors on the students they teach? **A4**: **Some** of that would come up in data governance, within the bounds of what can be shared in compliance with privacy requirements.
- **Q5**: Are the numbers related to our capacity? Is some of the projected growth beyond our capacity? **A5**: We need resources to be able to deliver on the plan. Some areas have room to grow; others will need development to welcome it.

- **Q6**: Some students drop out in the first year of their studies because of lack of preparation. Are we looking at remediation? **A6**: Yes, we are looking into that. There is a group looking at coordination of academic advising with an understanding of areas with greater attrition.
- Q7: Where are we going to house these extra students? I'm curious as to what we have stopped doing to do all the things we are taking on. A7: We must do things in quality, and it may be that some choice will have to be made about what we must continue. The Steering Committee will look at how much there is to do. It is noted that the University currently has a lot of room in its current housing capacity. The enrolment of 6000 students sounds scary, but we were almost there in 2023. The UPEISU's study on student housing is noted as an important source of good recommendations regarding the improvement of housing at UPEI.

8. Question Period

- **a.** Questions and answers received from Placemats None received
- b. Questions Received in Advance

Two questions were received in advance of the meeting from Senator Linkletter.

Q8: The calendar published this year organizes the table of contents differently than in the past. The current calendar does not have these sections and presents all 116 chapters sequentially. Was this reorganization of the table of contents intentional or an oversight? **A1**: This is a known issue that occurred when we cloned the calendar from a previous version. We are working to resolve that.

Q9: It seems we have transferred the review and approval of all transfer course equivalents for UCE to the main campus at UPEI. What is the reason for this policy or decision? **A2**: There have been some inconsistencies between UCE and UPEI in awarding credits. We are moving this into the hands of the associate Dean in Cairo.

c. Questions Received from the Floor

Q10: Is the University planning on posting the new position of Special Advisory on student engagement? **A10**: The position has been posted and applications received. We are evaluating candidates.

Q11: Why are new positions in the EDI office not unionized? **A11**: We are in the process of reviewing everything about those roles. We will keep that in mind. Those roles may deal with confidential content and could handle cases related to their own union, which could be problematic.

Q12: As it comes to data governance under the SEM Plan, there may be a role for the library as it has been looking to records management. **A12:** Noted.

Q13: Are we tracking where our graduates are? Are we sharing that information? A13:

We stay in touch with graduates to have information about where they are and what they do. We are working on better collection of data. The MPHEC has a lot of data about graduates that could be a place to start.

9. Reports from Standing Committee

a. Senate Steering and Nominating Committee

The Chair reports verbally that the Committee's only decision since the last meeting of the Senate is the approval of today's agenda.

b. Academic Planning and Curriculum Committee

Vice President Naterer brings to Senate three recommendations from the *Academic Planning and Curriculum Committee*, the first two regarding a change to English Language Proficiency (ELP) requirements and the corresponding Calendar entries and the third being a change in the title of a course delivered at the Atlantic Veterinary College (AVC): VBS 8030.

Changes to English Language Proficiency Requirements

The Changes to ELP requirements are in response to changes in English Language Program delivery and the introduction of new tests.

MOTION: MOVED by G. Naterer and SECONDED by B. Montelpare, that the English Language Proficiency requirements for Graduate Studies and the concordant Calendar entries be modified as presented. CARRIED

MOTION: MOVED by G. Naterer and SECONDED by M. Turnbull, that the English Language Proficiency requirements for Undergraduate studies and the concordant Calendar entries be modified as presented. CARRIED

Change in the title of a course at the AVC

MOTION: MOVED BY G. Naterer and SECONDED by P. Bernard that the title of course VBS 8030 be modified to add the words "and professional skills." CARRIED

10. Appointment of a Senator to the Board of Governors

The University Secretary indicates that, as prescribed by the University Act and the Processes and Procedures of Senate, a Senator is to be elected by Senate to a three-year term on the Board of Governors, with immediate effect. The elected members will attend their first meeting on October 7, 2025. The election is done from the floor of Senate with the candidate receiving the most votes being elected.

After a call for nominations and election by Senators, Senator John McIntyre was elected.

11. Report of the Board of Governors to Senate

Senator Montelpare reports on the business of the Board that has transacted since the

Senate last met. The Board has held a special meeting to approve the purchase of a property on Belvedere Avenue and approve the renewal of the Debt Facility for the Faculty of Medicine. The Board also held a joint information session with the Senate on the University's Strategic Plan.

12. University Strategic Plan

President Rodgers indicates that the final version of the University Strategic Plan has been circulated with the meeting materials. The plan was developed through a rigorous and consultative process, that included a joint session of the Senate and the Board of Governors on August 25. The Plan now goes on to the Board on October 7 for approval.

Thanks to Charlotte McCardle who headed the process, to members of the Steering Committee and to the Marketing and Promotion Unit, who have formatted the plan.

The shift towards the pursuit of excellence was noted as a positive move.

13. Policies on Harassment and Discrimination and Sexual Violence

President Rodgers presents the final version of two policies, the Policy on Harassment and Discrimination and the Sexual Violence Policy. These policies were developed in response to the Independent Review with an aim to replace the Fair Treatment Policy, under which some members of the University Community were hurt. The intent is to provide a safer and more respectful environment for members of faculty, students, and staff. Although the Policies are to be enacted by the Board of Governors, in a spirit of transparency and accountability, they are brought before the Senate for information.

The Chair invited questions or comments. There were none.

14. Shout Outs

Shout outs were sent to:

- Andrew Zinck from the Department of Music, who has received the Distinguished Teaching Award from the Association of Atlantic Universities.
- Julie Vanleeuwen produced the University's first research magazine.
- Colleagues of Nursing for receiving temporary accreditation for nursing programs.
- Those who organized a welcome week this year, with Johnathan Hewitt leading the charge. It was Bigger and better than ever!

A major program must contain a minimum of six courses at the 3000 or 4000 level. A laboratory/field component includes an introduction to water analysis techniques and field equipment, field water analysis, the collection and analysis of biological samples, and the physical properties of water. The second part is a field/lab project on a limnological topic tailored to the student's individual program, and consists of an experimental or observational study coupled with a comprehensive literature review, project write-up, and oral presentation. A laboratory component includes an introduction to, and an assignment regarding geographical information systems and their use in hydrology. Laboratory work will include water analysis techniques and instrumentation.

Rationale for New Course: Upon completion of their final year of study, basic skills in diagnostic imaging are expected for those veterinary students wishing to pursue a career in equine or mixed large animal practice. Currently within the AVC curriculum, opportunities for hands-on practice and experience with the different diagnostic modalities currently used in a field setting, such a radiology, ultrasonography, upper airway endoscopy and gastroscopy, are limited. This course was designed to address this gap in training and provide students the knowledge and experience needed to utilize theses modalities within their final year of clinical training and entrance into clinical practice.

Briefing Note Inclusion of "Indigenous Studies" on the Graduation Parchment

Senate Committee on Admissions and Degrees (SCAD) September 12, 2025

Issue

The new major in IKERAS, Indigenous Studies, was approved conditionally by MPHEC as a Bachelor of Arts, Major in Indigenous Studies. The words "Indigenous Studies" are essential to appear on the parchment, however with UPEI's current practice, the name of the program major does not appear on the parchment.

Background

Recently MPHEC reviewed the program proposal for the creation of a new undergraduate major at UPEI in Indigenous Studies. An excerpt from this review is provided below.

Our assessment found that Bachelor of Arts Major in Indigenous Studies was highly appropriate in terms of truth in advertising and credential recognition for the proposed degree, based on its structure and content. While we realize that the names of programs tend to get referred to in shorter form colloquially, in terms of formal naming, a DEGREE in (or of) XXX is notably different than a DEGREE with MAJOR IN XXX. Bachelor of Arts in Indigenous Studies denotes that the overarching degree (versus a field of study within) is in Indigenous Studies, which isn't an appropriate representation of the UPEI program (42 credit hours in the subject area). We see the "in" used more commonly in specialised undergraduate programs (e.g., Bachelor of Science in Nursing, Bachelor of Science in Medical Science, Bachelor of Arts in Health Promotion). These programs don't typically follow the major/honours structure, the subject is a part of the degree name, and correspondingly the overwhelming majority of the program is focused on the subject matter. Were UPEI to further develop the proposed program, in the future, for example, it might appropriately be renamed to Bachelor of Arts in Indigenous Studies (or Bachelor of Indigenous Studies) with or without majors in specific areas of Indigenous Studies.

Getting back to your original query, UPEI has more flexibility if you're only referring to the parchment. The cleanest solution, from the QA team's perspective, would be for UPEI to change its policy in terms of what it includes on parchments. This would also ensure equity across students/programs in terms of approach.

If this isn't an option, and you can't include "Major in Indigenous Studies" on the parchment as a one off for your institution, we'd suggest that you might consider the use of brackets (i.e., Bachelor of Arts (Indigenous Studies)). It's not a perfect solution, but it is a slight variation that is more ambiguous than the "in" which, as above, denotes a different program/credential. The transcript, academic calendar and other such documentation would then still have the fully spelled out "Bachelor of Arts, Major in Indigenous Studies."

Recommendation

That UPEI includes the name of the major on graduation parchments.

Rationale

Many Canadian universities include the degree name and the major on the parchment. Examples for Bachelor of Arts degrees include, but are not limited to, Dalhousie University, Acadia University, University of Regina, University of Alberta, Brock University, University of Calgary, University of Victoria, among others. However, UPEI does not include the name of the program major on the graduate parchment.

While not universal, it is common at Canadian universities to include the name of the program major, either as "Major in XXX" or through the use of brackets.

The home Faculty of the new undergraduate major in Indigenous Studies is IKERAS. In this case, when the Bachelor of Arts degree is awarded to graduands of the program, it is essential to have the words "Indigenous Studies" on the parchment, either as "Major in Indigenous Studies", or "Bachelor of Arts (Indigenous Studies)".

Subject: Revised Sale of Course Materials Policy

ISSUE

A Review Committee has modified the Sale of Course Materials Policy (a Board policy) based on feedback received from the university community and Senate. This revision is presented to Senate for information and subsequently the Board for review / approval.

BACKGROUND

At the April 2025 meeting of Senate, substantial feedback and suggestions were provided for a proposed revision of the Sale of Course Materials Policy. Afterwards, feedback from the broader university community was also received. Some sample comments from this consultation are provided below.

- Sections 8.2 and 8.5 (Access to Course Materials and Grading Materials) are redundant and it is sufficient to indicate only the Bookstore in 8.2.
- Naming of the policy has changed so the prior Sale of Course Materials policy should be deleted.
- Specific criteria for exceptions should be outlined in Section 8.8 for bundling of assessment and course materials, including standards and criteria for exceptions.
- In Section 8.9, the stated cost limit of \$50 is too low and not possible in some courses.
- Section 8 doesn't address the challenges inherent in some programs where course and grading materials are bundled together.
- The policy should be a joint Senate / Board policy.
- It should be clarified what Section 6.3 (b) (Principles) means to "impose any costs" in the context of costs set by the vendor.
- The restriction of 6.3 (b) for assessment materials free of charge is challenging when some courses need interactive and online software as part of the learning process.
- In Section 8.6 (purchase), it's unclear what happens if the materials are only available by rental.

RECOMMENDATION

A Review Committee has considered the feedback received from the consultations and made further proposed revisions to the policy (attached recommended final version). The proposed revision is presented to Senate for information, and subsequently the Board for review / approval.

RATIONALE

The previous revision had 11 sections whereas the current proposed revision has been significantly shortened to 5 sections. The current version focuses on how students pay for course and assessment materials – not how or what course materials or assessments are selected by instructors.



BRIEFING NOTE

Six sections were removed to address the above and other concerns including academic freedom. Instructors have discretion, within the boundaries of academic freedom, to: (a) select course materials that their students will be assigned or recommended; and (b) assign grading materials.

Other clauses removed include the pricing limit on textbooks and the concept that a copy needs to be made available on reserve or through another mechanism. The librarian on the committee felt that the copyright provisions in many electronic textbooks prevent their ability to make them available in many cases.

The pricing cap was viewed as problematic in that prices increase rapidly and the policy would soon become difficult to enforce on this point. This clause too was deleted.

Given that a concern has been financial gain from assigning one's own textbook, the committee decided that the Conflict of Interest Policy should be the process used to adjudicate and determine when a conflict of interest standard is met.

The principle of requiring assessment materials, free of charge, is maintained in the revised version. The current document addresses the issue of payments to complete assessments. Course assessment, free of charge, has been an important point for students and the committee.

Several viable alternatives are provided in cases where students are required to purchase or license course materials, such as a free access code obtained from the publisher, a free centralized platform for secure sharing, OER, or alternative way for a student to demonstrate proficiency for the relevant course material.

- creation and adoption of Open Educational Resources where possible and reasonable. It further supports instructors in securing or developing open-access assessment materials and tools.
- 5.5 Instructors must include a list in the syllabus or course outline of all required Course Materials, including costs and whether they include assessments that will be part of a student's grade in the course (such as simulations, online quizzes, tests or assignments). If an instructor's role in authoring, editing, publishing, or distributing a Course Material is not listed on the Course Material itself, that role must also be disclosed in the syllabus.
- 5.6 In cases where students are required to purchase or license a Course Material to access an assessment, the instructor must either provide an alternative way for the student to access the assessment (such as a free access code obtained from the publisher, a free centralized platform for secure sharing, or OER) or provide an alternative way for a student to demonstrate proficiency of the relevant course material, provided that the student makes such a request at least ten days before the assessment. For further clarity, assessments can test students on the content of the Course Materials, but the assessment itself must be accessible to students free of charge.

Motion: It is moved that the revised policy entitled *Academic Accommodations for Students with Disabilities* be approved by the UPEI Senate.

Purpose

The attached proposal is submitted for Senate consideration and approval. It outlines a significantly revised academic policy entitled Academic Accommodations for Students with Disabilities. The existing policy under the same name dates back to 2015.

Background and Rationale

Following a review of out-of-date academic policies, Senate approved the creation of an ad-hoc committee to revise this policy because of the time lapsed since the previous revision and most especially because the current version of the policy does not adequately reflect changes in Human Rights legislation nor does the current policy fully clarify respective responsibilities of various stakeholders with regards to the provision of academic accommodations for students with disabilities. The proposed revised policy responds to these realities and is aligned with current Human Rights legislation and case law, University regulations, and effective practices across comparable institutions.

Consultation and Endorsement

This policy has been reviewed and endorsed by APCC on October 7, 2025. Throughout the revision process, the following groups were consulted on an earlier draft of the proposed revised policy:

- -Dean's Council
- -the Faculty Association
- -The Student Union
- -The Graduate Students' Association
- -Student Services
- -Accessibility Services

Moreover, the draft revised policy was reviewed by internal and external legal counsel.

Summary of the Proposed Revised Policy

Senators are receiving a marked version of the 2015 version of the policy with changes tracked using the traditional strike-out and underline tactics. However, Senators may find this version of

the document difficult to read because the Committee did such an extensive revision to the policy, due in large part to the amount of time that has passed since this policy was reviewed and because of a rapidly evolving Human Rights context with regards to accommodations for individuals with disabilities.

The main substantive revisions to this new *draft revised policy include*:

- Updates to reflect current Human Rights legislation;
- An expanded and updated set of definitions of key terms and concepts relating to the accommodations realm;
- A clarification of the respective responsibilities for implementation of the policy.
 Responsibilities of Faculty members have been added to the key players in student learning and success.

1. **Purpose**

- 1.1 The University of Prince Edward Island, founded on the tradition of liberal education, exists to encourage and assist people to acquire the skills, knowledge, and understanding necessary for critical and creative thinking, and thus prepare them to contribute to their betterment and society through the development of their full potential.
- 1.2 To accomplish these ends, the University's community of scholars engages in teaching and learning, scholarship and research, and offers service for the benefit of our Island and beyond.
- 1.3 The University encourages the full participation of all students, including students with Disabilities, as members of the University Community, and strives to ensure Equitable treatment and access to University services, programs, and facilities.
- 1.4 Recognizing the Duty to Accommodate and Human Rights Law¹, the University commits to providing Reasonable Accommodations to the point of Undue Hardship and Equitable opportunities for students with Disabilities, within a supportive and challenging environment and consistent with academic principles.
- 1.5 The University seeks to remove physical, attitudinal, and systemic barriers that may impede or prevent academically qualified students with Disabilities from participating fully in university life. The University understands that persons with Disabilities may have different methods for achieving success and that effective accommodation may include variations in curricula, delivery, and evaluation methodology.

2. Scope

2.1 The Policy shall apply to:

2.1.1 all full-time, part-time, and unclassified students self-identified as having with a documented functional limitations or needs related to a Disability that adversely affects their ability to fulfill the requirements of an academic course or program, at the University of Prince Edward Island on and off campus, online, or in experiential education opportunities, including but not limited to practicums, service learning, cooperative education, internships, and land-based learning.

- 2.2 The Policy shall conform to provisions of:
 - 2.2.2 the Prince Edward Island Human Rights Act.

3. **Definitions**

- 3.1 Academic Accommodation An adaptation or extension of the University's resources, or a variation of teaching, learning, assessment, or evaluation procedure, that reduces or eliminates barriers in the academic environment without compromising Essential Educational Requirements. Disabilities and functional limitations may be permanent, temporary, or intermittent. Academic Accommodations enable students with Disabilities to perform the essential requirements of their academic program, although how students with Disabilities meet these requirements and standards may vary. Academic Accommodations are accessed through Accessibility Services on an individual basis.
- 3.2 *Disability* The term disability is an ever-evolving concept under Human Rights Law but may include a functional limitation caused by a long-term, temporary, or recurring physical, sensory, mental, psychiatric, or learning impairment that restricts the ability of a person to perform the activities necessary to participate in learning.
- 3.3 Documentation -Written information from a regulated health care professional verifying the student has functional limitations that are the result of a Disability, Disclosure of a specific Disability or diagnosis to Accessibility Services is not required. Students with a Learning Disability must provide a summary of a psychoeducational assessment conducted by an appropriate registered psychologist. Documentation is submitted and kept confidential with Accessibility Services.
- 3.4 Duty to Accommodate The Duty to Accommodate is an ever-evolving concept under Human Rights Law but generally means that sometimes it is necessary to treat someone differently to prevent or reduce discrimination. In such cases, the Duty to Accommodate may require that alternative arrangements be made to ensure that a person or group can fully participate. The Duty to Accommodate applies to needs related to protected grounds of discrimination under the PEI Human Rights Act, such as Disability. It is a legal requirement that post-secondary institutions adjust rules, policies, or practices to enable individuals to participate fully.
- 3.5 Equitable A principle of fairness in treatment, access to opportunity, and advancement for all members of the University Community. It requires acknowledging that treating people equally does not always produce fair outcomes, and there is a need to eliminate systemic barriers and biases that have played a role in impeding the full participation of underrepresented or disadvantaged groups.
- 3.6 Essential Educational Requirements The knowledge, skills, and/or abilities that must be acquired and/or demonstrated for a student to successfully meet the learning outcomes, course objectives, or degree-level requirements of a particular course or program, and if applicable, any professional licensing or accreditation requirements.
- 3.7 Reasonable Accommodation Adjusting a course, program, policy, procedure, or physical environment that adversely affects a student with a Disability without changing Essential Educational Requirements. Such Academic Accommodations must be provided in a way that respects the dignity of the student with a Disability to the point of Undue Hardship to the institution.
- 3.8 Undue Hardship The onus is on the University to prove Undue Hardship. Although Undue

Hardship must be considered in the context of each case, a finding of Undue Hardship could be supported in the following four (4) circumstances:

- 3.8.1 financial cost is such that the operation of the University and/or its programs would be fundamentally diminished, or a program or service would cease to exist due to the financial burden of the Academic Accommodation. Significant costs related to a requested Academic Accommodation shall be considered in the context of the University, not based on the individual department, division, faculty, school, or program.
- 3.8.2 there is a risk to public safety or a substantial risk of personal injury to the student with a Disability.
- 3.8.3 the Academic Accommodation unreasonably impedes the ability of other students to pursue academic studies.
- 3.8.4 when Academic Accommodation alternatives would result in requiring substantial alteration of Essential Educational Requirements.
- 3.9 *University Community* The University of Prince Edward Island as defined by the University Act, R.S.P.E.I. 1988, includes all members involved in the provision of University-related services including teaching, advising, administering, and other support services (e.g. instructors, administrators, counsellors, librarians, and support staff).

4. **Policy**

- 4.1 This policy affirms students' rights to be treated with dignity and respect, to have their privacy and confidentiality protected, and to receive Reasonable Accommodations based on documented functional limitations associated with a Disability. As such, the University recognizes:
 - 4.1.1 its legal obligation and Duty to Accommodate students with Disabilities.
 - 4.1.2 all University Community members including students, staff, faculty, volunteers, and contractors are legally obligated to adhere to the Duty to Accommodate.
 - 4.1.3 it is the responsibility of all University Community members to support and facilitate the University in meeting its Duty to Accommodate.
 - 4.1.4 its responsibility to provide Reasonable Accommodations to all otherwise qualified students registered with Accessibility Services.
 - 4.1.5 that failure to provide Reasonable Accommodations where required by law may be considered discrimination and may be addressed through the University's <u>Fair Treatment Policy</u>. (new policy name to replace this once approved)
 - 4.1.6 the provision of Academic Accommodations that permit students with a Disability to access courses shall not compromise Essential Educational Requirements.

4.2 This policy encourages dialogue between Accessibility Services, instructors, and students as to how the needs of individuals can be accommodated within terms of legislation and current University guidelines. All such dealings require mutual understanding and respect from the parties involved in the accommodation process.

4.3 Admissions:

- 4.3.1 Potential students with Disabilities who are academically qualified will have access to the University's educational programs, facilities, and services, to the point of Undue Hardship.
 - 4.3.1.1 Students with a Disability have the same recourse as other applicants in that they may appeal, through Documentation, to the Manager of Admissions or Admission Committee. Decisions of the Admission Committee are final.
 - 4.3.1.2 Students with a Disability who meet the current admission requirements for entrance to the University of Prince Edward Island are expected to follow the current admission procedures unless accommodation is requested.
 - 4.3.1.3 Students with a Disability shall recognize that admission to the University does not guarantee that Academic Accommodation for a Disability can be made.

4.4 Accommodations:

- 4.4.1 Students with a Disability who seek Academic Accommodations at the University of Prince Edward Island are responsible for bringing the request to the attention of the appropriate personnel in Accessibility Services, and for providing the relevant Documentation of their Disability in a timely manner. Delays in notifying Accessibility Services personnel may result in Academic Accommodation requests not being processed in time for the term or course in which the Academic Accommodation is sought.
- 4.4.2 It is recognized that students with documented Disabilities may require certain Academic Accommodations not required by other students to demonstrate their achievement of academic objectives. Nevertheless, it is required that students with Disabilities will satisfy Essential Educational Requirements.
- 4.4.3 Academic Accommodations are guided by the needs of the students, the recommendations within the professional Documentation, and the resources available at the University.
- 4.4.4 Generally, an Academic Accommodation is effective as of the date on the letter of accommodation.
- 4.4.5 Academic Accommodations will be considered and assessed in a timely and responsive manner.
- 4.4.6 Academic Accommodation decisions will be reviewed as requested and adjusted when necessary.

4.5 Appeals:

- 4.5.1 Students who believe they have not been treated fairly under this Policy should discuss the matter with a designate from Accessibility Services and the Course Instructor.
- 4.5.2 If consensus cannot be reached between the student, instructor, and designate of Accessibility Services, the student can follow <u>Undergraduate Academic Regulation 12.8:</u>
 <u>Academic Appeals or Graduate Academic Regulation 9: Appeals</u>

5. **Responsibility**

- 5.1 The University
 - 5.1.1 Through the Office of the Registrar, makes decisions respecting admission to the University and is responsible for ensuring that persons with a Disability, once identified, are given Equitable consideration for admission.
 - 5.1.2 Provides Reasonable Accommodations up to the point of Undue Hardship.
 - 5.1.3 Promotes an attitude of respect within the university for persons with Disabilities.
 - 5.1.4 Maintains confidentiality of the information obtained under the Freedom of Information and Protection of Privacy Act (FOIPP) and University policies (<u>Access to Information and Protection of Personal Information and Privacy Policy</u>).

5.2 Faculty and Instructors

- 5.2.1 Recognize and comply with the University's legal Duty to Accommodate.
- 5.2.2 Understand their role in helping to implement Academic Accommodations as outlined by Accessibility Services.
- 5.2.3 Engage in the Academic Accommodation planning process and consider a range of approaches and reasonable solutions to maintain Essential Educational Requirements while implementing Reasonable Accommodations, if requested.
- 5.2.4 Contact Accessibility Services if they have questions or concerns regarding Academic Accommodations.
- 5.2.5 Maintain confidentiality under this policy.

5.3 Accessibility Services

- 5.3.1 Accessibility Services, is the primary unit responsible for supporting students with Disabilities seeking Academic Accommodations.
- 5.3.2 Reviews Documentation to ensure that recommendations and decisions regarding Academic Accommodations are based on appropriate medical assessments and/or psycho-educational information.

- 5.3.3 Develops an individualized accommodation plan in collaboration with the student and any medical professionals that would outline the student's particular needs.
- 5.3.4 Provides information and support for students with a Disability in a timely manner.
- 5.3.5 Communicates the Academic Accommodations for which the student is eligible to faculty, instructors.
- 5.3.6 Communicates the Academic Accommodations for which the student is eligible during experiential education opportunities, including but not limited to practicums, service learning, cooperative education, internships, and land-based learning, to Coordinators, supervisors and preceptors of these external experiential education opportunities.
- 5.3.6 Advises students registered with Accessibility Services on strategies to open a dialogue with instructors, acting as a consultant, facilitator, or coordinator, and advocating for Academic Accommodations when necessary.
- 5.3.7 Raises awareness within the University Community about the Duty to Accommodate.
- 5.3.8 Maintains confidentiality under this policy.

5.4 Students

- 5.4.1 Initiate contact with Accessibility Services and make their functional limitations and need for Academic Accommodations known.
- 5.4.2. Provide the necessary Documentation to support the need for Academic Accommodations. The University does not provide or assume the cost of diagnostic services.
- 5.4.3 Actively and fully cooperate in the planning and implementation of Academic Accommodations.
- 5.4.4 Meet academic program and Essential Educational Requirements.
- 5.4.5 Inform Accessibility Services if there are any changes in accommodation needs in a timely manner.
- 5.4.6 Accept Reasonable Accommodation options proposed by Accessibility Services, faculty or others as needed. Students may refuse a reasonable accommodation but doing so may lead to no accommodations in this instance.
- 5.4.7 Meet deadlines that support the University's ability to provide Academic Accommodations.
- 5.4.8 Advise Accessibility Services of concerns if Academic Accommodations are not implemented.

Introduction

As the academic governing body of the University, the Senate has authority over academic policy and standards, ensuring the integrity, quality, and advancement of teaching, learning, and research. Senators play an important role in academic governance, contributing their knowledge and perspectives as representatives of faculty, students and staff in shaping academic decisions and priorities.

To fulfill these responsibilities effectively, senators must receive timely and relevant education.

This two-year plan (September 2025 – August 2027) is informed by feedback from a survey of senators on training needs and delivery methods, the UPEI Action Plan and the Senate's role as defined in the University Act.

The plan aims to balance the needs of new senators, through annual orientation sessions, with ongoing professional development of experienced members. Most training will be delivered by the University Secretary unless otherwise noted.

Attendance will be tracked, as required by the Action Plan, and participants will be asked to provide feedback to ensure continuous improvement of future training sessions.

ACTION

That the Senate approve a modification to the Processes and Procedures of Senate making the University Secretary the Secretary of Senate.

BACKGROUND

One of the results of the Governance Review was the creation of the position of University Secretary and the establishment of a University Secretariat. The intent was to strengthen support for the University's governance and ensure coherent, professional and rigorous support to the University decision-making bodies.

The original focus of the Review being the Board of Governors, attention was first given to bolster support for the Board and its committees; to ensure proper oversight of operations, procedural autonomy and enable the Board to be the institution's corporate fiduciary entity.

As the University's governance is bicameral, assuring coherence of governance practices is best served by having the University's chief governance officer handle both the Senate and the Board. This promotes a more seamless transition of decisions where both the Senate and Board are involved. There is value in ensuring a continuum of governance support across the spectrum of senatorial, managerial and corporate responsibilities for a host of issues that require an integrated and holistic perspective of the University's governance apparatus.

The transfer of responsibilities from the Registrar to the University Secretary does not remove all governance responsibilities from the Registrar, who will continue to support the work of some committees of Senate, namely the Senate Academic and Student Discipline Committee and the Academic Planning and Curriculum Committee.

Under section 4.3 of the Processes and Procedures of Senate, the responsibility of the Secretary of Senate is:

- a) receiving and compiling submitted agenda items for the Senate Steering and Nominating Committee.
- b) providing expertise in Roberts Rules of Order (the most recent edition; the most recent In Brief edition is also acceptable).
- c) working with the Senate Assistant to ensure maintenance of records for Senate.

- d) serving on the Senate Steering and Nominating Committee.
- e) arranging elections to Senate vacancies as required.

RECOMMENDATION

That the Processes and Procedures of Senate be modified by removing from section 4.3 the word "Registrar" and replacing it with "University Secretary" with effect at the close of the September 26 meeting of Senate.

Report to Senate

From Senator member of the Board of Governors, W. Montelpare

October 24, 2025

Since the last meeting of Senate, September 26, 2025, the Board has held its Annual General Meeting and an Open Session on October 7, 2025. During those sessions, the following were discussed:

- Approval of the University's Financial Statements for the fiscal year ended April 30,
 2025
- Approval of the Board's Annual Workplan for 2025 -2026
- Approval of the University's Strategic Plan for 2025 to 2030
- Reception of the report on the Audit of the Action Plan
- Reception of Annual Reports from the Chair of the Board, the President and Board Committees
- Repeal of the Visual Identity Policy and its replacement with a new policy
- Discussion of Harassment and Discrimination and Sexual Violence policies
- Reception of quarterly reports

Financial Statements

The Board received a clean opinion from its External Auditors, Doane Grant Thornton. The Statements are available to Senators as part of the meeting materials for the Annual General Meeting of the Board. Vice President Walker also presented an overview of the University's financial status based on financial viability indicators developed by the Canadian Association of University Business Officers (CAUBO).

Board's Annual Workplan

For the first time, the Board approved an annual workplan for itself, which fulfills one of the University's commitments under the Governance Review. The plan was derived in good part form workplans developed by all committees of the Board. Those plans were provided to the Board and the Community for information. The workplan brings greater predictability to the Board's activities and allows Board members to deliver better oversight of key University activities.

Strategic Plan

The Board approved the Strategic Plan of the University for 2025 – 2030. The final plan approved is available on the University's website and in the materials for the Open session of the Board. The plan is now in effect.

Action Plan Audit Report

The Board received a report from Deloitte on the implementation of the Action Plan for years 0 and 1. The report points out that UPEI has delivered on 95% of activities under the Action Plan; a percentage qualified by the auditors as impressive. The report of the Auditors was priorly presented to Senate and to a joint meeting of the Campus Culture Oversight Committee and the Finance, Audit and Risk Committee.

Annual Reports

The Board received annual reports from the Chair of the Board, the President and all its committees. These reports are part of the materials for the open session of the Board, which can be consulted on the University's website.

As part of her report, the Chair of the Board noted the increased conjoint events and activities of the Board and Senate, which signals a clear effort on the part of the University to ensure that its apex decision-making bodies work hand-in-hand in delivering on the University's mandate.

Visual Identity Policy

A new Visual Identity Policy was approved, which replaces that old policy. The next policy provides clearer processes and terms and better defines the responsibilities of members of the University Community in the use of the University's visual identity.

Harassment and Discrimination and Sexual Violence Policy

With some questions still unresolved and members having submitted some suggested edits, the Board withdrew the policies and asked that the Steering Committee revisit the text for future consideration. The Board expects the policies to come back to it for approval in the near future, for which it may hold a special meeting before the planned quarterly meeting on December 2, 2025.

Quarterly reports

With the Board's schedule now based on four meetings a year, the Board receives quarterly reports form each committee that has met since the last Board meeting. Those reports are available as part of the meeting materials for the October 7 meeting of the Board.
