1. Convocation 2020

Parchments and transcripts will be available the middle of May. The Registrar's Office will coordinate getting these to graduates.

MOTION (D. Dahn/L. Doiron) that there be an extension to the deadline for submission of marks for Winter 2020 semester to May 1 and with this change, that the May Senate meeting be moved from May 1 to May 8. CARRIED.

MOTION (K. Gottschall-Pass/R. MacDonald) that the Senate will not make a definitive date for convocation but meet at a future date to decide.

2. Spring 2020 Session

Given the rapidly changing COVID-19 situation, Spring Session was discussed.

MOTION (K. Gottschall-Pass/T. Mady) that Spring Session courses be moved online except Clinical Courses in the Faculty of Nursing and Clinical rotations in the Faculty of Veterinary Medicine.
