President Keefe called the meeting to order at 3:03 pm.

#### 4. <u>President's Report and Question Period</u>

President Keefe highlighted recent campus events, including the Truth and Reconciliation KAIROS Mass Blanket Exercise, the celebration of Southern Indian (Kerala) culture, the opening of the UPEI Performing Arts Centre and renovated Dr. Steel Recital Hall, the Distinguished Alumni Awards, and the Inspiring Young Alumni Awards. Additionally, with the assistance of the Alumni Association and a generous donor, UPEI facilitated the participation of two busloads of students in an inspiring event in Halifax featuring Michelle Obama.

President Keefe mentioned the rescheduled Board of Governors/Senate meeting on November 17th and highlighted the interest expressed by IKERAS faculty members in having faculty representation on the Board of Governors. He also mentioned his presentation to the Standing Committee on Education and Economic Growth of the provincial government, focusing on UPEI's initiatives in response to the Rubin Thomlinson recommendations. Addressing priorities in the sexual violence prevention office and EDI will require collaboration with the province.

Also, the President's listening sessions continue on campus—having met with nine faculties to date. Themes that are surfacing from these sessions are being shared with the Action Plan Advisory Group.

President Keefe provided an update on official enrollment numbers, citing a 5% increase overall with significant growth in Graduate Studies, and the Faculty of Arts.

In response to a question asked at the last meeting, President Keefe shared that UPEI by the numbers reports that by April 2023, the number of UPEI faculty will be up by 11 permanent faculty members compared to the previous year. B. Waterman requested a breakdown specifying which faculties are represented amongst these 11 new members.

- B. Linkletter asked for clarification on the policy pertaining to faculty members who hold an administrative role and are on administrative leave. President Keefe indicated that the former president resigned in Dec 2021 and was therefore not included in calendar for subsequent year.
- G. Naterer shared that UPEI received over \$1.6M in NSERC Discovery Grant and RTI funding earlier this year, a 60% increase over the previous year and highest ever annually for these two programs. UPEI's total research funding for 2022-23 is \$14.1M, a 30% increase over last year. Congratulations to faculty researchers and special thanks to staff support in the research office especially Leslie Cudmore.

Additionally, UPEI Business students have recently excelled in national and regional case competitions including first place at the Travel and Tourism Research Association Annual Conference in Kingston, and annual ASB (Atlantic Schools of Business) competition.

Two new Canada Research Chairs have been announced: the first being "Children, Youth and their Educational Geographies," a collaboration between the Faculties of Education; Indigenous Knowledge, Education, Research, and Applied Studies; Nursing; and Arts. The second is "Equity in Nutrition, Physical Activity, and Health," in the Department of Applied Human Sciences.

Concerns were raised around regulations discouraging the potential beneficial use of generative artificial intelligence (AI) in courses. It was explained that the intention of the motion is to address potential academic integrity issues related to AI use. Specific wording adjustments were proposed to address proper use. The motion remains as is however and a working group on generative AI will further examine this area and consider student use of AI in view of academic integrity.

ii. Teaching and Learning Centre 2022-2025 Strategic Plan

It was decided that strategic plans with university-wide scope are to be submitted to Senate for review / approval. But strategic plans of individual academic units within UPEI should be presented to Senate for information purposes only.

iii. UPEI Centre for Entrepreneurship with Work-Integrated Learning

G. Naterer presented this outreach centre as endorsed by the APCC committee as an initiative to support student entrepreneurship and make these experiential learning opportunities more broadly accessible to all students across campus. Financial support was provided by the Atlantic Canada Opportunities Agency and Innovation PEI, in partnership with the Startup Zone. Special thanks to Dr. Tarek Mady, Dr. Reuben Domike and Megan MacLean. Renovation work in the Pit (across from the entrance to the Robertson Library) will begin in December.

Questions were raised about sustainability after two years of ACOA / IPEI funding, use of space, reporting structure, naming, and the need for Senate approval when the funded project is already underway.

#### Senate Meeting Minutes - October 20, 2023

The initiative will benefit students by creating new entrepreneurial experiential learning opportunities through the Experiential Education Department at UPEI. A Manager of Entrepreneurship will lead the implementation of student programming activities and plan to grow the student entrepreneurial culture on campus. They will manage the space and allow other groups to share space when not used for student entrepreneurship. Senate feedback and suggestions will be taken back to APCC to address questions raised with the proposal.

#### iv. Retention and Removal of Digital Course Materials Procedure

Senate discussed this new procedure which addresses the retention and removal of old course materials and digital recordings from UPEI's learning management systems. It was noted that in order to manage storage space costs, course material is archived after three years and permanently deleted after seven. Faculty access to archived material during sabbaticals, as well as a communication strategy to faculty members, were raised. A process to request access to archived material is available. Costs of multiple platforms and the need for a university-wide records management policy were noted.

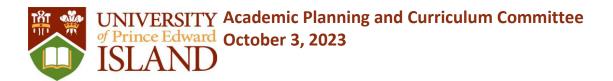
